### **Diminished Value Methodology**

Manhein Market Research in particular is very useful as it provides actual auction figures on actual automobile sales that are right up to date. We also rely on our over 30 years experience as buyers of used cars and trucks at the dealership and dealer auction level. The Fair Market Cash Value of a vehicle is defined as the figure that a dealer would pay for a car or truck on a cash basis, ie; not as a trade in. We use dealer purchases as the basis of our calculation since dealerships control over 90% of the used car market and therefore give the most objective and accurate values. The Diminished Value is the difference between the Fair Market Cash Value of the vehicle prior to the accident, and the post-accident/post-repair Fair Market Cash Value.
